What are Cookies?

Cookies are data files that are downloaded to your computer or mobile device when you visit a website or application.

Cookies are tools that play an essential role in the provision of many services of the information society. Among others, they allow a website to store and retrieve information about the browsing habits of a user or their equipment and, depending on the information obtained, they can be used to recognize the user and improve the service offered.

What types of cookies are there?

Depending on the entity, the term or the purpose for which the data obtained through the cookies are processed, these may be:

	Own Cookies	They are those that are sent to the user's terminal equipment from a computer or domain managed by the editor itself and from which the service requested by the user is provided.
Depending on the entity managing the domain	Third party cookies	Cookies are those that are sent to the user's terminal equipment from a computer or domain that is not managed by the editor, but by another entity that processes the data obtained through the cookies. In the event that cookies are installed from a computer or domain managed by the editor itself but the information collected through these is managed by a third party, they cannot be considered as own cookies.
According to the length of time they remain in	Session Cookies	Designed to collect and store data while the user accesses a web page. They are usually used to store information that is only of interest to keep for the provision of the service



storage		requested by the user on a single occasion (e.g. a list of products purchased).		
	Persistent Cookies	The data remains stored in the terminal and can be accessed and processed for a period defined by the cookie owner, which can range from a few minutes to several years.		
	Technical Cookies	Those that allow the user to navigate through a website, platform or application and the use of the different options or services that exist in it as, for example, control traffic and data communication, identify the session, access parts of restricted access, remember the elements that make up an order, make the buying process of an order, make the application for registration or participation in an event, use security features while browsing, store content for broadcast video or sound or share content through social networks.		
According to purpose	Personalization cookies	They allow the user to access the service with some general characteristics predefined according to a series of criteria in the user's terminal such as the language, the type of browser through which you access the service, the regional settings from where you access the service, etc Analysis Cookies: These cookies allow the party responsible for them to monitor and analyze the behavior of the users of the websites to which they are linked. The information collected through this type of cookies is used to measure the activity of the websites, application or platform and for the elaboration of browsing profiles of the users of such sites, applications and platforms, in order to introduce improvements based on the analysis of the usage data of the users of the service.		
	Advertising Cookies	They allow the management, in the most efficient way possible, of advertising spaces. They store information on user behavior obtained through the continuous observation of their browsing habits, which allows the development of a specific profile to display advertising based on the same.		
	Cookies from external social networks	They are used so that visitors can interact with the content of different social platforms (facebook, youtube, twitter, LinkedIn, etc) and are generated only for users of these social networks. The conditions of use of these cookies and the information collected are regulated by the privacy policy of the corresponding social platform.
